RL Okay. AMANDA BORTNER. Okay, and AMANDA, just for the record, it's November 9th and it's 20 past 4 in the afternoon and we're sitting here at the, you know where you are, at the Kittery Police Station?

AB Um, hum.

RL Okay, and again for the record, it's DET. ANGELA BLODGETT and myself, DET. LECLAIR, and we're assigned to the Criminal Division of the Maine State Police. Now, who's the father of ...

AB His name's ROBERT SHEEHAN, but he even says he's not the father, we never even had paternity hearing or anything, but he's the father.

RL Okay, when you say dad's, it's ROBERT ...

AB SHEEHAN, yes.

RL S-H-E-E-H-A-N?

AB Yes.

RL Okay, now, where does ROBERT live?

AB Somewhere in Sanford.

RL In Sanford, okay. Um, how old was the baby?

AB She'll be two (2) in February, February 4th.

RL Okay, and the baby's name?

AB KASSIDY BORTNER.

? I'm sorry, I was looking for JEN.

RL KASSIDY?

AB KASSIDY BORTNER.

RL Okay, and where are you from? What's your address?

RL Fourth day at Old Navy. Are you on any medication or anything?

AB Mum, hum.

RL None at all?

RL When was the last time you took an aspirin?

AB I never took an aspirin in my life.

RL Really?

AB I just like I couldn't swallow pills forever for some reason so I never really took Tylenol, either. I just started because I had to learn when ...

RL Have you had any alcohol?

AB ... neonatal. No.

RL So the only medication you take is, what was it prenatal?

AB Yup.

RL Okay.

AB Well, I've had Tylenol before, but not for a long time.

ACB You are not on any medication now?

AB Um, um.

ACB I know this is hard, but are you feeling okay about talking to us?

AB Well, yeah.

ACB Feeling sick or anything like that?

AB I feel like I'm going to puke, but ...

RL Well, if you get that feeling real bad, would you let us ...

AB Oh, diet pills.

RL You take diet pills?

AB Yeah.

RL When was the last time you took diet pills?

RL When was the last time you had anything to eat?

AB Um, my break at work today. I had soup.

RL What time was that?

AB Um, 11:30. 10:00. Somewhere around there.

RL Okay, and you have water. Do you want a sandwich or anything?

AB No, I can't eat right now.

RL Okay, but because of the nature of our job and our investigation, um, we have to read you your rights, okay?

AB Um, hum.

RL But you can get up and leave if you want to. Okay?

AB Okay.

RL But we're investigating the death of your child.

ACB We just want to make sure that you understand.

AB Does this always happen? Do you always have to do this?

ACB Pretty much. If dealing with a child and we're going to be talking to all of the caretakers, people

that had regular contact.

AB Okay.

ACB And, basically, it's just to make sure that you understand that you don't have to talk to us. Certainly don't mistake that are under arrest because you are not.

RL You are not under arrest and you are free to leave. I just got to get the Miranda Card.

AB Why would you say that though?

RL What?

ACB On tv they always arrest them and read Miranda and I don't want you to think that you're under arrest.

AB Oh.

RL You're not under arrest, okay. You understand that? If you feel like you gotta leave, you can just get up and leave, all right?

AB Okay.

RL You understand that?

AB Yes, I understand.

RL Okay. I am a law enforcement officer. I want to ask you some questions, before I do so I want to explain your rights. You understand that?

AB Um, hum.

RL Okay. You have the absolute right to remain silent. Do you understand that?

AB Um, hum.

RL Okay, when you say, "Um, hum." Can you say yes?

AB Yes.

RL Okay, and anything you say can be used against you in a Court of Law. Do you understand that?

AB Yes.

RL You have the absolute right to the advise of a lawyer before any questioning and to the presence of a lawyer here with you during questioning. Do you understand that?

AB Yes.

RL If you cannot afford a lawyer, one will be furnished to you free before any questioning if you desire. Do you understand that?

AB Yes.

RL If you decide to answer questions now, with or without a lawyer present, you have the right to stop answering at any time until you can talk to a lawyer. Do you understand?

AB Yes.

RL Okay. Now, having all those rights which I've just explained to you in mind and remind you, do you wish to answer any questions that Det. Blodgett and I would have?

AB Yes.

RL What does that mean to you, though? The Miranda? What I've just read to you?

AB What does it mean to me?

RL Yeah.

AB What do you mean?

RL Just summarize it.

ACB Paraphrase it to make sure you understand.

AB Um, that I'm not afraid to talk. I mean, I'd rather talk when I've moved, like in a couple days when I've moved out of state, but if you have to talk with me now I will.

RL Well, you understand that we're at the beginning stages of the investigation.

AB Yeah. I'll talk to you now.

RL We need direction to go. You understand that you are free to leave?

AB Yup, I understand.

RL You can have an attorney present?

AB I don't have an attorney.

RL You don't have to say anything.

AB Okay.

RL AMANDA, let's start out today. What did your day consist of from the time you got up?

AB Um, I woke up this morning, woke up, actually my daughter woke me up this morning. She was crying and woke up, took a shower, got her ready to leave.

ACB Do you know about what time you would have gotten woken up?

AB Um, 6:15, I had to be to work at 8:00. I got there at 8:20 though, but I got her ready first to leave. I gave her actually cereal in a bag to take with her because we were in a hurry. Got my

boyfriend's son ready to go, too, he goes to daycare.

RL What's your boyfriend's son's name?

AB KYLE EVANS.

RL Okay, KYLE EVANS?

AB Um, hum.

RL And, okay, go ahead, continue.

AB And then we went to, I dropped him off at his daycare in Dover and then I dropped her off at JEFF's and JEN's, my sister's. They I went to work.

RL Okay.

ACB How was everybody this morning?

AB She was really tired and like I don't know why I didn't think of her being sick, but she was really tired.

RL Okay, um, what did you dress her in this morning?

AB Um, actually, a brand new outfit. A fleece sweatshirt, fleece pants, I put on her Elmo slippers because I couldn't find her sneakers and her winter jacket and a hat.

RL Um, hum,

ACB Now, when you say that she was tired, um, was she just sleepy, or not,

AB Yeah.

ACB Like her head was bobbing?

AB Yeah. You know, like she's going to fall asleep.

ACB When they're struggling to stay awake?

AB Yeah, and last night on the phone, see I worked till 11, but didn't get home till 12, because it's like a half-hour drive. My boyfriend, well I called him on my break to see how she was doing and, just as I was calling, they were like, they play wiffle ball alot, and he was playing in the bedroom with both of the kids and the little boy was throwing the bat around, they fight alot. He's at that age, you know?

ACB What is his age?

AB Three (3)

ACB He's three. And KASSIDY's one and a half (1 1/2)?

AB Yeah. And he hit her in the eye with the ball, with the bat. They fight all the time.

AB Yeah, she's got like a big think on the side of her eye.

ACB And that would have happened last night?

AB Yeah. And then he told me that she was acting funny, and (Inaudible).

RL No, and how old was the baby?

AB She'll be two (2) in February.

RL Okay. So she's about 18 months?

AB Yup.

RL Um...

AB No, she's older than that. I don't know. I can't think too well.

RL Was she talking?

Yeah. Yeah, and that's why I didn't bring her to the doctor's because she's been so good. She was being so smart lately like she was surprising me. Like KYLE said, "1,2,3,4,5" the other day and she said, "6,7,8,9" and I couldn't believe it, you know? And then she says, she's been saying the ABCs and she's been pointing things out, you know? But I didn't think she was sick, I thought she was all better.

RL When you say all better, what do, what was a sick prior?

AB Well, um, about 2 weeks ago, she, JEFF was babysitting her and he brought her back and he told me that she fell out of the truck.

RL And JEFF being?

AB JEFF, he's the one that babysits for me. She was standing ...

ACB And he lives with your sister, JEN?

RL What's his last name?

AB MARSHALL.

RL Um, hum.

And, um, he said that she was sitting on the front of the car seat and, like WILL, the neighbor, said something like to pass a break or something, I don't know, something like that and he moved and then KASSIDY fell out of the truck and she had a bump on her head. And, um, she came home that day and she was really sick, she was like dehydrated and she wanted drinks and stuff, so I gave her Pedialyte and I gave her Tylenol and I kept giving her water to get some fluid in her and the next day she was fine. I was

going to bring her to the doctor's, but I thought she was better, you know, and actually that night, actually she was really tired, it was like 10 o'clock and her eyes went back a little bit and, um, I thought it was just because she was tired, but now, you know.

RL Do you know when that was?

AB It was late that night. Not when she fell (Inaudible).

RL Do you know how long ago it was?

AB I think it was like 2 weeks ago. Maybe 3 weeks ago.

ACB Did you talk to KASSIDY about falling out of the truck?

AB She doesn't talk that well.

ACB Okay.

AB Like I'll ask her, if I ever asked her if she feels good she, and ... he tripped over her the other day, like 2 days ago, and she hurt her leg and she was walking funny and ...

RL When you say, "He", who is he?

AB JEFF. And he told me that when I picked her up that she's walking funny because he had tripped over her. She was standing right behind him and I was like okay, and I like, was feeling her legs and I was asking her if it hurt because usually she says, "Ow" and she didn't say ow or anything.

RL Did you see her walk funny?

AB Yeah, she was.

RL Okay, how would you describe the walking?

AB It was just like a little limp, not even like a limp, but.

RL Um, hum, and ...

ACB Now, were you there when this happened?

AB No, I was at work. I'd been at work for, I just started a job, this is my fourth day, I've been working alot of hours so I haven't seen her, you know. Like last night I got home at 12 and she's was sleeping so I just didn't see how she was acting, you know?

RL Did you go in and see her last night?

RL Did you tough her? Give her a kiss or anything?

AB Yeah, well, I touched her head and gave her a kiss on the cheek.

ACB Um, now after JEFF tripped over KASSIDY, um, how long ago would that have been?

AB Two days ago, I think.

ACB Two days ago.

AB Around there.

ACB When she's in her socks, I haven't seen KASSIDY yet, but the doctor had mentioned injury to the bottom of her foot.

AB The doctor?

ACB Did she burn her foot or something?

AB No, actually, I saw that and, um, she came home from JEFF's house and he said that JEFF and JEN thought that, because there's like nails sticking up from the bottom of their floor, so that's why I brought over, brought her, put her in slippers also.

RL They have what?

AB He said that they have like, kind of, not like nails, but like, you know, sharp things.

RL Um, hum. When's the last time you gave her a bath?

AB Um, the day, actually, no, CHAD gave her one last night, I think.

RL CHAD gave her a bath last night?

AB Um, hum.

RL When you say you think, are you guessing or ?

AB I'm pretty sure, yeah. I was on the phone with him when they were in the bath.

RL What time was that?

AB Um, (Inaudible). My work would know, I was on break.

RL Yeah. Roughly, just ...

AB Around 7:30.

RL Okay.

ACB So, you gave her a bath maybe two days ago?

AB Yeah.

RL How, did you notice anything two days ago?

AB Uh, huh.

ACB She, what the report that we're getting, is that she has a lot of bruises on her.

AB She has bruises on her body?

ACB Yeah, have you noticed bruises in the last couple of days?

AB Just what was on her eye, right here and right here.

ACB So, both eyes?

AB Yeah, she hit the corner of the table. She's really, she's really like disoriented. She falls, well, she fell, alot.

ACB Is that a recent thing or ...

AB Yeah.

ACB Okay.

AB But she's always been like that klutz kind of, too.

ACB So she hit one eye with the wiffle ball and you weren't there for that CHAD had told you about that?

AB Yeah. I was there for like the glass table in the living room.

ACB And when did that happen?

AB Probably like three (3) or four (4) days ago.

RL When you say glass table, where did that ...

AB She had bruises on her body? They said that?

ACB It's what they've told us, I haven't been to the hospital yet and just to be honest with you, does anybody smoke?

AB Um, um.

ACB CHAD doesn't smoke? Or JEFF doesn't smoke?

AB Um, um. Nobody smokes. She's never around any smoke.

ACB Because I think that doctor thought that marks on her foot looked like a cigarette.

RL Describe her this morning when you the last time you saw her. KASSIDY. What was she doing? What were her behaviors?

AB Um, she said, "Drink". I gave her a drink.

RL Where was this?

AB In the morning.

RL Where?

AB At the house and I gave her cereal in a baggie.

RL Um, hum.

AB Oh, my God, I can't believe this.

ACB Was she hungry at all?

AB She hasn't been eating very well, like last night, actually, CHAD was telling me on the phone she didn't eat much and she was acting funny.

ACB How did, did he explain how acting funny?

AB No. Like, I don't know, like kind of sick. She didn't feel well, tired.

RL How long has CHAD been in the picture?

AB Probably for like, helping me take care of her for like four (4) months probably. But I've been with him for almost 6 months.

ACB How long have you been living over there full time pretty much?

AB Um, probably like 3 or 4 months.

ACB 3 to 4 months.

RL Okay, when you explain, um, ...

AB Maybe not even that long.

RL ... taking care of for 4 months, what do you mean by taking care of?

AB Just like, I don't know, helping me out, like picking her up and stuff.

RL Okay.

AB He doesn't like, he's babysit her like twice by himself, but.

Okay. You never dropped her ...

ACB Have you ever, have either CHAD or JEFF or even JENNIFER really, have ever done anything that made you feel like they got frustrated with KASSIDY easily or have they ever done anything that you had to say hey.

AB No, just yell at her.

AB They don't touch her. Like I would never let anybody touch her.

ACB Does anybody, what do you think happened then?

AB I have no idea like I didn't know about any of this. I knew about her feet and I knew about her eye, and that's what he told me right when it happened. And like you telling me about these bruises and I have no idea about any of this and then he told me she had bruises on her chin and then asked me if I saw it this morning and I didn't see anything. Oh, my God.

RL Is CHAD a good guy? I mean is he ...

AB Yeah, he's a really good guy.

RL I mean, has he ever been in trouble with the law?

AB Yeah, he's been, um, once, but he's like the best father. You can ask anybody.

ACB I mean 1 1/2 can be a pretty frustrating age, they need, like, round the clock ...

AB She's more whiny than, like, he's used to boys and she's a girl so he'd yell at her, but he'd never hurt her.

ACB Yeah.

RL Do they play rough?

AB Yeah.

RL When you say, when I say rough ...

AB Actually, I'll tell you that like I'd yell at him because he'd play a little too rough with her. He'd swing her around and stuff.

ACB Like by her feet or something?

AB I play with her like that, but she laughs and stuff.
