JL: Detective JEFFREY LINSCOTT, Maine State Police SH: Detective SCOTT HARAKLES, Maine State Police

- SH I appreciate, you know, keeping your head with us and, uh, giving us the time of day, what we have to do, um...

- JM I don't know if I got all the answers but...

- SH That's fine, whatever, whatever you know.

- JL Oh, bring her, bring her with you to the job site and everything?
- No, nope, um, you got to understand, she's still a little kid so she, you know, would tend to kind of wander and, um, but basically size and get something, you know. I mean we took her shopping, I mean when we lies the same was our own really, I mean.
- SH You don't have any kids?
- I don't have any kids, no, um, like I said I like kids, you know, I have a little brother that died of cancer when he was 11, you know, uh, this is why this bothers me quite a bit, um...
- SH So when did this scenario start where they would be in Rochester in the evening and then come and you would be the primary babysitter during the day. When did that first start?
- JM Probably a couple weeks ago.
- SH Couple weeks ago, and did they ask you to do that, did they call and ask you or...?
- JM Yeah, uh, the main focus of that was, and they felt that it wash't the right time to, you

- Me and her sister assumed things, you know, like there were bruises like right here on her chin, you know, and William my next-door neighbor came out and he says "Kassie came over, they don't look too big, but, man, she's got bruises right here, bruises right here," you know, those aren't bruises that when a baby, I think, when a baby falls, you know, would get something, you know, um...
- SH Now, the incident you're talking about is pretty recent, right?
- JM Yeah, when...
- SH When did you first start noticing bruises on this kid in the kid's lifetime?
- JM Inguess when she was abund Chad. I, I don't, let me first of all say this, okay, because Chad is, I consider him a friend of mine.
- JL Sure.
- JM We do landscaping for the guy, I got those two together, you know, I knew he had kind of a history, as far as abuse goes, um...
- SH How long ago was this, was this, when did he come into the picture?
- About three, four months ago, something like that when I got them two together, you know, and she basically started staying down there and she'd come up and say stuff to us, you know, and her, I guess her girlfriend in Rochester, and this will come into play when I tell you about today's phone call from them, but I'll tell you that later, uh, would say stuff about her bruises, you know and...

- up to Auburn, because her parents moved from Sanford to Auburn to this new house, they didn't want to bring her up there and this is another incident where I got a phone call, "can you come down can we bring Kassidy over to you guys to watch her because we're going up

- SH Did you ever, never saw a cut that raised your eye, that was always, is it safe for me to say ...

- SH The most serious thing you saw was some suspicious bruises.

JL Jeff, has she ever required any, uh, medical treatment for anything you've seen, ever any trips to the hospital, to the ER or anything like that?

She got sick, uh, over at our house and I kind of thought she should have went to the hospital then, but, um, they kind of wanted to wait because obviously she had oursel, you know, on her face and they were more concerned with...



BORTNER'S mother was identified as AMANDA BORTNER, DOB: 1-21-82. KASSIDY BORTNER and AMANDA BORTNER live at 191 Milton Road, Rochester, NH with the mother's boyfriend, CHAD EVANS. BORTNER was being babysat at 51 Rogers Road, Kittery by JEFFEREY MARSHALL, DOB: 3-21-75 and MARSHALL'S girlfriend, JENNIFER CONNELLY, who is also AMANDA BORTNER'S sister. MARSHALL'S neighbor, WILLIAM PIERCE, of 6 Johnson Court, Kittery, had information that MARSHALL was concerned about the bruises on KASSIDY BORTNER. EVANS and MARSHALL are reportedly friends. The injuries sustained by KASSIDY BORTNER were described as being extensive bruising on the body and head that included retinal hemorrhaging. There was also scabbing found on the soles of KASSIDY BORTNERS feet and there was also a possibility of sexual abuse. MARSHALL had made statements that when KASSIDY BORTNER arrived at his residence this morning, there were two marks on her face that appeared as if she had been grabbed around her chin. MARSHALL reported that KASSIDY BORTNER had been dropped off at his residence yesterday at 4:15 PM and that EVANS had picked up KASSIDY BORTNER from MARSHALL'S residence at 5:30 PM yesterday. MARSHALL also reported that AMANDA BORTNER dropped off KASSIDY BORTNER at MARSHALL'S residence this morning at 8:15 AM while MARSHALL and his girlfriend, JENNIFER

CONNELLY, were home. JENNIFER CONNELLY works at Perfumania, a perfume store, AMANDA BORTNER works at Old Navy clothing store, JEFFEREY MARSHALL is a self-employed landscaper and CHAD EVANS works for McDonalds as an area representative. The 911 call came in at approximately 12:30 PM from MARSHALL. He had noticed problems with KASSIDY BORTNER and had called CONNELLY for advice.
