11-9-00

1330 hours: I was directed by Sgt. MATTHEW STEWART to respond to the Kittery Police Department regarding the investigation into a child death.

1500 hours: I arrived at Kittery Police Department and was briefed by Sgt. STEWART as to the following:

CASSIDY BORTNER, d.o.b. 2-4-99 died on 11-9-00 while in the care of baby sitter, JEFFREY MARSHALL, [REDACTED]. The unconfirmed cause of death appeared at that point to be physical abuse, possibly long term. CASSIDY currently resided with her mother, AMANDA BORTNER, d.o.b. [REDACTED] and her mother's boyfriend, CHAD EVANS, [REDACTED] in Rochester, New Hampshire.

1611 hour: Det. JEFFREY LINSCOTT and I conducted a video taped interview with JEFFREY MARSHALL at Kittery Police Department. See Det. LINSCOTT'S report for transcript of that interview.

1955 hours: Det. JEFFREY SMITH and I conducted an audio taped interview with JACQUELINE CONNOLLY [REDACTED] JACQUELINE is AMANDA BORTNER'S natural mother. See Det. SMITH'S report for summary of that interview.

2133 hours: I interviewed TRAVIS C. HUNT, [REDACTED] at Kittery Police Department. TRAVIS is currently AMANDA BORTNER and CHAD EVANS' housemaid. See attached summary of interview.

11-10-00

1140 hours: Det. STEVE HAMEL of Kittery Police Department and I interviewed JEFFREY MARSHALL at Kittery Police Department. This taped interview was the second time I had spoken with JEFFREY MARSHALL. See transcript of interview for further information.

11-13-00

1000 hours: I attend a briefing at Kittery Police Department on the BORTNER investigation.

11-22-00

1100 hours: On this date and time New Hampshire State Police Troop Detective, JILL ROCKY and I interview TRAVIS C. HUNT [REDACTED] Rochester Police Department. See Det. ROCKY'S report for transcript of that interview.
