TE I called last week probably like a week or maybe two weeks before that I had gone over to Chad's house and Amanda and Cassidy had been staying there and I walked in and at first I thought like she had dirt all over her face or something and then I got closer and it wasn't dirt it was bruises all over her face and across her neck. And I just like bent down and I was like oh my Cassidy honey what happened to you? And she never says anything which I think is odd. And ah Amanda just looked at me and I said what happened to her? Like questioning and she goes oh she fell on the stairs and I like looked at her and I thought falling down the stairs I have two boys that is not falling down the stairs. That's okay they were like little and then I said to Chad the following day when Amanda wasn't around and said what happened to Cassidy's face she's got like bruises all over her you know. He goes then he said she was on the trampoline which they have and he said and she fell off she like went to fall off the edge and he caught her. I'm like okay and I said well it doesn't look like falling off a trampoline bruises. He was like well I don't know. And I said well Amanda said she fell down the stairs. He goes I don't know I didn't ask. And I'm like okay. And then just what actually made me call DYCS last week was she had another bruise on her right cheek and it was like a almost like a black bruise it was like a deep bruise and I was like okay so maybe I'm overly reacting maybe I'm not but I said I'm going to give them a call and it's just because it's not normal she doesn't even act normal. And then I saw her two days ago and she had another bruise on her cheek and I was like okay I don't as far as Cassidy goes not acting normal. I started mentioning to Chad after I saw the bruises I said you have a child you know what a year and a half old kid acts like. And I said she's not acting normal I said I'm not trying to be mean or throw punches but is there something mentally wrong with her I said because she doesn't do things that a one and half year old do. I said she doesn't talk, she doesn't play she just sits there. You sit her in a chair and she would sit there for hours. And not move. I'm like that's not normal that's not you know. I'm like you need to start asking some questions here. Two days ago I said to him cause I don't she was just like crying when I, I've gone over to the house before and she'll be upstairs shut in the bedroom just like balling. And I'm like I hate that because she's only one and a half one in the house I mean I'd never do that to a kid. (inaudible) and I found I just thought it was weird I just had a feeling that something else was going on. And I was like I'm just going to give DCYS a call anyways home when I leave and I made it anonymous because if I was wrong I didn't want any body to pissed off at me.

Um I said but she just had bruises aren't normal like kid bruises that I would call normal kid bruises I said maybe I'm wrong I said but I would just feel more comfortable letting somebody else know and maybe it can looked into. And that's basically (inaudible)

JL Hm, hm so you don't know um you don't know Amanda other than to you've spoken with her before?

TE Oh yea, I've spoken with her and I've sat and talked with her for a few times. Um when I first met her she didn't really have Cassidy until recently. I know that she like I was introduced to Amanda at the beginning of the summer. And she did not have Cassidy like hardly even until probably maybe two months ago. And she was with Amanda's mother. Up until that point. And just recently she's had her all the time. And I was like okay yeah I just thought it was odd that she didn't have her at first when she was there. That's okay. It was just little things. I didn't you know I don't know.

JL So you're there ah dropping off your kids and picking your kids

TE I'm there probably every other day.

JL Is visitation that, that frequent every other day or

TE Um Chad has our son Tuesday's and Wednesday's, Friday's and every other weekend. And it like um this past Tuesday I picked Kyle up because he was at a meeting. And then he came over to my apartment and picked him up it's you know if somebody needs something done it's very flexible

TE No but one thing that she had done that I did not like was one of the times I had gone there they Chad has a dog. Sometimes when he goes in there the dog barks it was four o'clock in the afternoon and Kassidy was sleeping. And I guess the dog woke her up so she was crying so I walked inside and Amanda went up stairs and grabbed Kassidy and she was holding her by the waist she stood in front of the mirror she moved her hand and Kassidy was crying she goes well just shut up and turned around and I went back outside and I came back in and Kassidy was shut up stairs in the bedroom screaming. I'm like hey it's 4 o'clock in the afternoon it's not like bedtime and I didn't say anything it would make her mad at me whatever. I'm just like maybe that's her time out but I would never lock a one and a half year old in the bedroom.

JL Um Amanda had gone on with you in any of your conversations about ah where she's from or ah anything like that?

TE Um she said that she was from Auburn and that recently her parents had just moved to Buckfield or something like that.

JL Okay so ah Kyle ah being three after he has gone over there to visit um have you noticed any um bruises or anything?



TE Um absolutely not.
