On November 17, 2000 at approximately 1230, **Detective Callaghan** and I, Detective **Gero**, met with:

We met with **Erin** in the Director's office at Cross Road Kindergarten Center. **Erin** advised that last Wednesday, November 8, 2000, between 1230 - 1245 she was standing in her classroom. **Erin** observed a white or light colored vehicle pull into the Kindergarten's parkinglot. She observed a female operator and a small female child sitting in the driver side rear seat. The child was wearing a pink coat and possibly a white hat or a hat with a white trim. She observed the female operator get out of the vehicle and remove a male child. **Erin** was able to identify the male child as **Kyle Evans**. The female carried **Kyle** into the Kindergarten and stated to **Erin** that **Kyle** had just come from a Doctor's appointment and that he had eaten something already. The female then left the building, returned to the vehicle and left the area.

Erin asked Kyle who the woman was that had just dropped him off. Kyle advised her that her name was Amanda.

Erin describes the female, Amanda, as having long, wavy, blond hair, small face, 5'6", average weight, glasses and wearing a coat. Erin remembers her appearing to be young.

Later that same evening at approximately 5:20 pm, Chad Evans came to the Kindergarten to pick up Kyle. Erin did not observe him drive into the parking lot. Chad walked into the K3 room where the children were watching a movie, VEGGIE TALES. They always watch a movie from 5 - 5:30 pm and Erin remembered Chad showing up near the end of the movie. He questioned Erin as to where he could get the movie for Kyle. Chad then got Kyle's lunch box from his cubby and left. Erin estimated that he was present for approximately 2-3 minuets. Erin did not observe any unusual behavior. She stated that Chad was wearing a suit and tie.

Erin also advised that Monday evening, November 13, 2000, Tristin came to pick up Kyle. Tristin stated to her that she did not think that Chad "did it" and does not think that Chad would do anything like that because Kyle is ok. Tristin went on to say that Chad told her that on Wednesday evening, November 8, 2000 he gave Kassidy a bath. Chad's room mate commented on how Kassidy did not have any bruises that day but Thursday she did.
