at the Kittery, Maine Police Department. Parsons is a co-worker of Amanda Bortner's at Old Navy in Kittery, Maine.

Parsons said Amanda started work on November 2, 2000. Once Amanda finished training and starting working they began talking. One day they were talking about Amanda's boyfriend. Amanda said he had a lot of money. He was great, Amanda said. Nice, good looking. A half an hour later the story changed. Amanda started telling Parsons She wanted to get away from him. She said he was an asshole. Parsons asked Amanda why he was an asshole. Amanda didn't answer, then walked away. Amanda told Parsons, Chad was 29. Amanda wanted to go out, Chad wanted to go to dinner parties. Amanda told Parsons, "I am getting sick of him. I want to break up with him."

Amanda told Parsons Chad had a 3 or 4 year old. Amanda had to get both kids ready. Pick out their clothes. He (Chad) didn't do anything in the morning.

Parsons said Amanda didn't talk about her daughter much. Amanda was young when she got pregnant. Amanda told her it was a one time thing. When she lived with her parents, Amanda could go out because they would stay with the baby.

On November 9th, Amanda got the call. She came back from the phone crying. She said, "My baby, my baby." She (Amanda) said, "My little girl fell off a truck and now she's at the hospital. My sister's boyfriend was watching her." Amanda told Parsons this as she was running toward the door. Amanda said she fell off the truck 3 or 4 times. She has (was in) a coma.

Amanda said she had been running late that morning. At 8:00 she was still trying to get the kids ready. Amanda told Parsons, Ramone had said Chad was controlling. (Ramone Aguilar is another Old Navy co-worker).

Parsons said that was all she really knew, Amanda hadn't been working at Old Navy for very long.
