Of particular note are telephone calls made from line 08 (flex/holding area telephone) from 11-22-00 through 01-05-01. These calls were made to C. EVANS home telephone number (335-7966) after C. EVANS was discharged from the jail. A total of seventy-eight calls were attempted, seventy-two were denied, six were successful. The completed calls occurred on 11/22, 26, 28, two on 12/3 and one on 12/13. See attached records, incorporated herein by reference.
