# Hearing delayed in toddler death case

ROCHESTER — A probable cause hearing for a local man accused in the beating death of his girlfriend's daughter has been rescheduled

for Jan. 8.



Chad E. Evans, 29, of 191 Milton Road was charged Nov. 16 with manslaughter in connection with the death of 21-month-old Kassidy Bortner. To date. his probable cause hearing in Rochester District Court has been rescheduled

Evans faces one charge of manslaughter. However, a Strafford County grand jury could come back with additional or increased charges once it meets this month.

Although the Maine Chief Medical Examiner's Office has not released its official report, police allege that Kassidy's death Nov. 9 at York Hospital in York, Maine, was the direct result of abuse inflicted at the hands of Evans. New Hampshire Assistant Attorney General Christopher Carter said last month that preliminary autopsy results indicate the toddler died from blunt force injury to her head.

According to police, Kassidy's aunt, Jennifer Conley, and her live-in boyfriend, F. Jeffrey Marshall, periodically took care of the toddler at their Kittery home while Kassidy's mother worked. Marshall said Amanda Bortner, 18, dropped her daughter off at his Rogers Road home around 8:30 a.m. Nov. 9.

Marshall called Kittery police seeking emergency medical services for Kassidy about 12:40 p.m., after what authorities describe as a "dramatic decline" in her health. She was pronounced dead at York Hospital about 1:30 p.m.-

According to Carter, the charge against Evans is the result of "an intensive, coordinated investigation by Maine and New Hampshire law enforcement authorities including Kittery. Rochester and state police. He said the decision to bring charges in New Hampshire is based on evidence related to the cause, nature and timing of the child's fatal injuries.

Carter confirmed late Tuesday afternoon that the probable cause hearing for Evans had been rescheduled for Jan. 8 at 10:30 a.m. in Rochester District Court. Beyond that, however, he would not comment on the case. Previously, Carter said because the investigation is ongoing, few specific details can be

Bortner has not been charged with any crime in connection with her daughter's death. Bortner lived with Evans in the Milton Road

residence at the time he allegedly beat Kassidy to death. Police will not say, however, if Bortner was present Nov. 8 and 9, the dates Evans allegedly inflicted the fatal injuries on her child, or whether they expect charges to be filed against her.

It has been a little more than, a, month since Kassidy's death, and police in both states continue their

investigation.

"We are working to piece together the details of Kassidy Bortner's life in the days, weeks and months leading up to her death," Carter said following Evans' arrest. "We are seeking some measure of justice in this utterly senseless act."

Following his arraignment on the manslaughter charge in November. Evans spent less than a week at

Strafford County House of Corrections before his \$100,000 bail was posted through Denis Bail Bonds of Raymond. The individual or entity that posted Evans' bail requested anonymity of the bond company.

In addition to the manslaughter charge, Evans must return to court in January on charges he violated his probation on a simple assault conviction against his former wife,

Tristan Evans. Evans' probation conditions included not possessing firearms and not being arrested on any other charges.

Although the autopsy on Kassidy's body was completed Nov. 10, the Maine Chief Medical Examiner's Office in Augusta is continuing to withhold the results pending further analysis.
