## Child abuse covered up, records say

## Ex-Keene man accused in death; mom, baby sitter protected him

ROCHESTER — The mother and relative who baby-sat a 21-month-old girl knew she was being abused months before she died, and protected the abuser, court documents allege.

Kassidy Bortner died Nov. 9. Her mother's boyfriend, Chad Evans, 29, is charged with second-degree murder and with eight charges of assault. Evans, a Keene native, is a former member of the Keene Board of Education.

According to court records, Evans had beaten Kassidy repeatedly during a three-month period, threw her against walls, and broke her leg and arm in separate incidents last summer and fall.

The court documents also indicate the child died after months of abuse that her mother; Amanda Bortner, 18, and two babysitters were aware of, but did not report.

Rochester District Court unsealed the documents on a motion filed by The Keene Sentinel.

Initially, authorities suspected Kassidy may have been sexually assaulted, too, but further investigation indicated that wasn't so.

Kassidy was pronounced dead at York (Maine) Hospital, where she was taken after Bortner's sister's boyfriend called authorities to report she was unresponsive. Evans had left the girl at the sitter's home in Kittery, Maine.

Although Kassidy died in Maine, Evans faces charges only in New Hampshire, because that's where he allegedly inflicted the

child's fatal injuries.

While Maine authorities assisted in the investigation, "based on the evidence gleaned thus far ... we do not expect to bring charges in the state of Maine regarding the death of Kassidy Bortner or any other offenses against her," said Maine State Police Sgt. Matthew Stewart.

According to court documents, Bortner told police she knew of several instances when Evans beat the child. She told authorities Evans had pressed on her throat and on the child's throat during could not bring Kassidy to the doctor's office because she had bruises from Evans' conduct." Both also allegedly agreed to lie about the cause of Kassidy's death.

Assistant N.H. Attorney General N. William Delker said he could not comment on any charges that Bortner, Marshall or Connelly might face for allegedly cooperating to hide the abuse.

Delker told The Sentinel this morning that suspicions about sexual assault were raised during examinations immediately following her death. After further investigation, Delker said, no evidence now exists that Kassidy was sexually abused.

"The state does not allege at this time, based on the status of the investigation, that there was sexual abuse," said N.H. Assistant Attorney General Christopher Carter. "The evidence that has developed over the two-month investigation so far has not created a basis for that to be part of the charges at this time."
