Rescue responded and transported KASSIDY to York Hospital and declared dead. The attending physician observed extensive bruising on KASSIDY's head, face and body. 1430 Hrs. I was advised to respond to Kittery Police Department and assist in the investigation of an infant death.

1530 Hrs. I arrived at Kittery Police Department. Several State and Kittery Police Detectives were already present, and I was provided with the following background information by SGT. MATTHEW STEWART:

At approximately 1242 hrs., JEFFREY MARSHALL telephoned 911 and reported that KASSIDY BORTNER, age 18 months, was unresponsive at his residence located at 53 Rogers Road in Kittery. 1530 Hrs. I interviewed AMANDA BORTNER at the Troop B Barracks in Gray. This interview was video taped (Item AB-5) and transcribed. See, Transcript of Interview, attached. See also, Evidence Control Sheet, attached.

NOVEMBER 16, 2000

1225 Hrs. SGT. JAMES WHITE of the New Hampshire State Police and I interviewed AMANDA BORTNER at Kittery Police Department. This interview was video taped (Item AB-6) and transcribed. See, Transcript of Interview, attached. See also, Evidence Control Sheet, attached.

2130 Hrs. I received a telephone message from WILLIAM PIERCE indicating that it "struck him as odd" that KASSIDY BORTNER and her step-grandfather have similar color hair and noses. PIERCE also expressed concern that AMANDA BORTNER used to "engaged in behavior her family thought was weird" such as leaving KASSIDY at her parents' home and driving off.

NOVEMBER 18, 2000

1100 Hrs. I attended KASSIDY BORTNER's memorial service at Andrews Funeral Home in Buckfield. Others present at the service who signed the guest registry included

1841 Hrs. I spoke over the telephone with CATHY NORMBERG and AMANDA BORTNER who advised me that AMANDA would be traveling to Texas in the morning and staying there with CATHY indefinitely. I was provided a forwarding address for AMANDA of 2503 Jackson Kellar, Apt. 118, San Antonio, TX 78230 and a contact telephone number of [REDACTED]

NOVEMBER 21, 2000

0930 Hrs. I spoke over the telephone with AMANDA BORTNER in Texas. AMANDA recalled that on or about 10/31/00, KASSIDY fell forward in her car seat and hit her head on the back of the driver seat in AMANDA's vehicle. This occurred because the belt holding KASSIDY's car seat was not "clicked all the way in" and AMANDA had to hit her brakes suddenly to avoid a collision. KASSIDY did not cry or seem injured after the incident.

NOVEMBER 22, 2000

1035 Hrs. I received a telephone call from WILLIAM PIERCE who indicated that he had heard rumors that CHAD EVANS would be arrested within three (3) days of KASSIDY's death and that that he believed AMANDA BORTNER had left the State of Maine because she was going to be arrested as well.

JANUARY 10, 2001

1330 Hrs. I placed Items AB-1 through AB-6 (original audio and video tapes) into the CID I Evidence Locker in Gray. See, Evidence Control Sheet, attached.

NICOLE HARVEY is CHAD EVANS' sister. She had limited contact with KASSIDY BORTNER and did not spend much time with her. NICOLE had noticed a bruise on KASSIDY's forehead and "something on her foot" in the past. She questioned AMANDA BORTNER about these injuries, and AMANDA offered reasonable reasons for them. NICOLE did not suspect KASSIDY was being abused.

NICOLE last saw KASSIDY on Sunday, 11/05/00. On that date, CHAD stopped by her home with KASSIDY. KASSIDY had a small bruise on her cheek, and NICOLE asked CHAD about the injury. CHAD told her he did not know how KASSIDY had gotten the bruise. While at NICOLE's house, KASSIDY sat quietly and slept for awhile. She did not cry at all. NICOLE attempted to engage KASSIDY in play, but KASSIDY was unresponsive to her attempts. NICOLE suspected that KASSIDY might be developmentally delayed, and she noticed that KASSIDY did not put her arms out to brace herself when she stumbled or fell.

NICOLE has never seen AMANDA or CHAD act inappropriately with KASSIDY. She denied any history of abuse in her family and indicated that she has never known CHAD to be abusive.

VIRGINIA GROVER is the Secretary for the Chief of Police at Kittery P.D. She was working on 11/09/00 when AMANDA BORTNER came into the station and was told that her daughter had died. AMANDA was crying and very upset, so VIRGINIA got her some water and sat with her in the conference room and kitchen areas of the police station. VIRGINIA also sat outside with AMANDA for about 45 minutes after AMANDA stated she was feeling sick and needed some fresh air. She tried to comfort AMANDA and make sure AMANDA didn't feel alone while she waited for her family to arrive and for the police officers to speak with her further.

While VIRGINIA was with AMANDA, AMANDA made several spontaneous statements including the following: "What am I going to do now? I had a baby when I was young, and now I've lost a baby when I'm young."; and "I should have taken the baby to the doctor. She was sick, and I gave her Tylenol. It's all my fault."

AMANDA's sister arrived at one point, and VIRGINIA sat in the conference room of the police station with the two women. She heard AMANDA's sister ask what had happened. AMANDA

then told her sister that the baby had been sick, that she gave it Tylenol, that she should have taken it to the doctor, and that their mother was coming and was going to be upset.

RCL - You know, this is the guy you live with. This the guy who's paying for your apartment \$70000 a month. He's giving you a mortgage. You know, he's worried about it. Every time I hear for me she falls down or hurt, and the guy is like, 'KYLE with the, what's the ball? And then he says you should have anything to do with her? And you just said you this guy trying to cover himself...

AB - Well, I've been trying to get an apartment. Like, I've, but then I was like, I don't know, I thought that it, you know, would get better and, I don't know.

RCL - You know, you told us, I mean, the most precious thing to you yesterday was your daughter. Now she's gone. This is where you, you can help her.

AB - I know.

RCL - I mean, you've got auntie and uncle out there spilling their guts telling us everything they know, and we have to come to you two times to get the truth on something.

ACB - Alright. Because other people are telling us, like two (2) weeks?

AB - I noticed that she was like tired and she was spacey and that one time, um, when she fell out of the truck that day, that night, and her eyes, I thought she was just tired, and I thought that was kind of weird. AB - I really, honestly, don't think he'd do that. Like, I think, he just loses his temper, but I think it was like must have been the dirty diapers. There was, ah, CHAD wouldn't even change the diapers in the beginning. You know?

ACB - Yeah.

AB - Like, and JEFF. Whenever she was like with him there (inaudible) shitty diaper that she had all day.

ACB - Yup.

AB - Maybe that might be what it was?

ACB - So no, no unusual sexual...
