ROBERT SHEEHAN stated that KASSIDY BORTNER was probably his child, biologically, but he had no desire to include the child in his life as he already had a child and didn't really know the mother, AMANDA (CONLEY) BORTNER. SHEEHAN knew AMANDA BORTNER as AMANDA CONLEY and was not even familiar with the BORTNER name when initially asked about AMANDA. SHEEHAN stated that AMANDA wanted him to take a paternity test to determine who the father was, but he did not take one. SHEEHAN stated that he slept with AMANDA twice, once at his birthday party when he provided her alcohol. SHEEHAN stated that all sex with AMANDA was consensual.

SHEEHAN stated he used to go out with CRYSTAL MARTIN, and CRYSTAL knew AMANDA and would sometimes baby sit KASSIDY. SHEEHAN stated that CRYSTAL told him that AMANDA would sometimes lock KASSIDY in a closet when the baby would cry. SHEEHAN stated he saw the baby once at CRYSTAL'S apartment when AMANDA was visiting and AMANDA said, "Did you see your baby?" SHEEHAN stated he saw the baby one other time outside a store for just a minute. SHEEHAN stated he did not see any marks or signs of abuse on the child when he saw it, but that he wasn't looking at the child much.

SHEEHAN stated he does not know CHAD EVANS and has never seen him before. SHEEHAN stated he has heard rumors around town about the death of

KASSIDY and that CHAD EVANS caused KASSIDY'S death. SHEEHAN commented that he knows a lot of people in Concord State Prison and that people like CHAD EVANS are not well liked in prison.

GABE SNYDER stated that he met AMANDA BORTNER in 1996, they dated, she became pregnant, he thought he was the father, they went to birthing class together, she eventually told him the baby might not be his, and he got a paternity test done which showed he was not the father of the baby. SNYDER stated that KASSIDY BORTNER was born in February 1999 and they started living together in April 1999. SNYDER stated the paternity test was done in November or December 1999 and the results came back in January 2000. SNYDER stated they moved out from living together in August or September 1999.

SNYDER said that some of his friends told him that AMANDA had cheated on him, which he did not believe at the time. SNYDER said that AMANDA told him that BOBBY SHEEHAN was the father of the child. SNYDER said that AMANDA told him (SNYDER) that SHEEHAN had only met KASSIDY once, had never held her and had no active role in her life. SNYDER said that he knows BOBBY SHEEHAN and sees him occasionally around town. SNYDER said that SHEEHAN has admitted to him that he slept with AMANDA and has said that "the baby might have been made with his sperm, but he is not the father". SNYDER said his only contact with SHEEHAN lately is when they occasionally meet on the street and their only conversation is in making fun of AMANDA as neither of them like her now. SNYDER said he has been able to disassociate

himself with AMANDA and KASSIDY since finding out he was not the father. SNYDER said that he and AMANDA did not utilize any birth control when dating.

SNYDER stated that he never saw AMANDA get physical with KASSIDY. SNYDER said that AMANDA was a young, immature person who had a baby before she was emotionally ready to have one. SNYDER said that AMANDA got frustrated with KASSIDY at times, but she would leave the room and pass KASSIDY off to SNYDER instead of taking out her anger on KASSIDY. SNYDER stated that he saw KASSIDY fall down twice in the time he lived with them and get bruises. SNYDER stated he was there both times and no injury was inflicted on KASSIDY, all bruising was the result of an accidental fall. SNYDER said that KASSIDY was a tough kid, and that she did not bruise or cry easily.

SNYDER stated he did not have much contact with AMANDA or KASSIDY BORTNER during 2000. SNYDER said that AMANDA brought KASSIDY into the store in March 2000 and they decided to "call it quits" and not have any more contact between them anymore.

SNYDER stated he does not know CHAD EVANS and has never met him before. SNYDER said that when he last spoke with AMANDA around March 2000, she told him that she was dating CHAD EVANS and she was bragging about how rich he was. SNYDER stated that he does know JENNIFER CONLEY, AMANDA'S sister, and JENNIFER'S boyfriend, JEFFEREY MARSHALL. SNYDER stated that he dated AMANDA for four years and knows all of her family and got along with all of them. SNYDER stated that he "hung out" with JEFFEREY MARSHALL and they watched movies together.

SNYDER stated that AMANDA'S mother had KASSIDY most of the time as far as babysitting went. SNYDER said that KASSIDY lived with AMANDA and him until they moved out, and then KASSIDY went to AMANDA'S mother's house to live. SNYDER stated that EMILY CONLEY was their roommate while living together and CONLEY babysat KASSIDY at times. SNYDER said that AMANDA'S mother and stepfather, PAUL, took good care of KASSIDY.

SNYDER said that AMANDA and JENNIFER argued over anything, like clothes, when they were together and SNYDER does not think they got along well or had much to do with each other. SNYDER said that AMANDA never mentioned herself being abused at all. SNYDER stated that AMANDA has hit him in anger in the past. SNYDER said that they would put KASSIDY to bed before they did any fighting. SNYDER stated that he never hit or spanked KASSIDY, citing abuse by his mother's boyfriend which taught him to never hit women or kids. SNYDER said that when he got frustrated with KASSIDY, he would put her in her crib with her pacifier. SNYDER stated that when AMANDA would hit him, he would push her away in self-defense, but he never struck her.

I was directed by Sgt. Matthew Stewart to respond to the Kittery Police Department regarding a death of a child.

1515 hrs

I arrived at the Kittery Police Department and was briefed by Sgt. Matthew Stewart. Sgt. Stewart told me that Kassidy Bortner (2/4/99) had died and it may be the result of physical abuse. He told me the mother of Kassidy Bortner was Amanda Bortn and Amanda was presently at the Police Department. He indicated to me that Kassidy had been babysat by Jeffrey Marshall at his Kittery residence when she experienced a midical problem. Jeffrey Marshall then had called the Kittery rescue. When rescue arrived, Marshall was performing CPR on Kassidy. Sgt. Stewart told me that Kassidy and Amanda live at her mothers boyfriend house in Rochester, New Hampshire. The boyfriends name is Chad Evans Stewart told me that Chad Evans had babysat Kassidy last evening from approximately 1730 hrs until Amanda returned home from work home around 2400 hrs.

Visual examination revealed the presence of several faint red brown stains on this paper napkin. Presumptive chemical tests for the presence of blood were positive on each of these stains. On 1-11-01, a cutting from one of these red brown stains was submitted to the Forensic Biology Section of the Crime Laboratory for HemaTrace (a confirmatory test for the presence of human blood) and or DNA analysis. Illumination with an alternate light source revealed the presence of several other stains on this napkin. On 1-11-01, a cutting from one of these stains was also submitted to the Forensic Biology Section of the Crime Laboratory.

1832 Hrs. I met with Detectives at Kittery Police Department and was briefed on the

preliminary case information.

2107 Hrs. I conducted a consent search of the JEFFREY MARSHALL residence at 53 Roger road in Kittery authorized by MARSHALL. Security tape surrounded the apartment and a Trooper posted security outside upon my arrival. I took

photographs of the apartment.

Medical supplies were on the porch that leads to the front door of the MARSHALL apartment. Evidence was collected from the residence and an Evidence Control Sheet was maintained. Pajama bottoms(State Police Evidence#: HML-1), baby slippers(HML-2), and a pink baby coat(HML-4) were on top of the bed in the single bedroom to the apartment. A yellow "fast-food" type napkin(HML-3) with stains and a zip lock bag containing a chocolate cereal(HML-5) were also on the bed. The bedsheets, pillow covers, and comforter were collected.

The kitchen and bathroom had linoleum floors and the bedroom and living room with carpet floors. No sharp protrusions from the floors were observed that could have produced the pattern injuries noted on the feet of (S1) BORTNER. A bowl spaghetti-o type soup was in the sink.

A mostly full package of diapers were in the bathroom. No used diapers or baby formula were found in the apartment.

The search of the MARSHALL residence was completed and a copy of the inventory was given to JEFFREY MARSHALL. I spoke with MARSHALL about evidence collected from his apartment. (See enclosed copy of Inventory and Summary of Interview).

He said there was no toilet paper or paper towels so he used the napkin. The Spaghetti-o's in the sink were fed to the baby the day before. The cereal found on the bed was the last food given to (S1) BORTNER according to MARSHALL.
