

at her residence. The purpose of the interview was to determine what contact BULLARD had with AMANDA and KASSIDY BORTNER, and CHAD EVANS. BULLARD substantially stated the following. She has known A. BORTNER since about the seventh or eighth grade. She also had contact with KASSIDY when she was an infant, while A. BORTNER was still living in Sanford, ME. BULLARD said she did not know CHAD EVANS prior to KASSIDY'S death. BULLARD said she and A. BORTNER'S friendship had soured prior to A. BORTNER meeting EVANS. Their friendship was re-kindled when A. BORTNER called BULLARD following KASSIDY'S death. BULLARD said she felt sorry for A. BORTNER because her family wasn't supporting her and felt she should put aside past hurts in light of what had happened to KASSIDY.

BULLARD said for a time, she had considered driving to Texas with A. BORTNER but then decided against it. BULLARD said she believes it was sometime in July 2001 that she moved to Vermont and lived in a trailer, in the woods, with A. BORTNER. BULLARD said the trailer was small and she believes it was owned by EVANS' brother, JASON EVANS. BULLARD said she believes the name of the trailer was "Sprite", or "Spirit", or "Sprint". BULLARD said the trailer was moved out to the site by EVANS' father, CHESTER EVANS. BULLARD said the trailer was situated on family land, down the road from EVANS' grandparents' farm. BULLARD said the trailer was at a logging "landing" where felled trees were brought by skidder. BULLARD said the logging was being done by EVANS' brother, RONNIE EVANS. CHAD, JASON, and CHESTER EVANS occasionally assisted with the logging and cutting wood. BULLARD said that she and A. BORTNER even helped by marking hemlocks, in the woods, for cutting.

BULLARD said that EVANS spent two to three overnights a week, with A. BORTNER, at the trailer. BULLARD also said that one time EVANS' son, KYLE EVANS, came out and spent the night with EVANS, A. BORTNER, and BULLARD. BULLARD said there was also a tent set up for sleeping space.

BULLARD said she last saw and spoke with A. BORTNER in late July or sometime in August. BULLARD said it was shortly after A. BORTNER was served with a subpoena for court.

BULLARD told us that A. BORTNER told her that she believes JEFF MARSHALL is responsible for KASSIDY'S injuries. I asked BULLARD what A. BORTNER had told her about that. BULLARD said that A. BORTNER told her that one time she picked up KASSIDY from J. MARSHALL'S and she had fallen from his truck. BULLARD had asked A. BORTNER if she had taken KASSIDY to the hospital. A. BORTNER said she had not because KASSIDY was okay. BULLARD questioned why A. BORTNER hadn't, because at least then there would have been a hospital record, regardless of whether the incident was an accident or not. The only other thing A. BORTNER told BULLARD was that KASSIDY had some pricks on her feet that she believed came from MARSHALL'S house.


BULLARD described A. BORTNER as a "drama queen" and said that A. BORTNER "doesn't know reality and just wishes it had never happened". BULLARD said she had moved back to Maine because A. BORTNER was starting to pick at her and put her down, which she didn't appreciate. BULLARD also explained that she and JASON EVANS had been dating but when she moved back to Maine he didn't pursue the relationship further.

I asked BULLARD if she knew that A. BORTNER and EVANS were not supposed to have contact. BULLARD said she did know and stated rhetorically "When you love somebody so much, what choice do you have."

I asked BULLARD what she and A. BORTNER had done for money. BULLARD said that she had worked for one week at the Brattleboro, VT, McDonald's Restaurant and A. BORTNER had worked at Pizza Hut. BULLARD said that A. BORTNER had some money in the bank. BULLARD also said that they "shopped smart" eating things like "Oodles of Noodles" which they cooked by boiling water out of the river.

The interview concluded at about 1145 hours.
