# Father gets 30 years in death of his child

## Man served time for shaking first son

NASHUA - Barry Linde pleaded guilty Monday to second-degree murder in the shaking death of his 2-month-old boy and was sentenced to 30 years to life in prison.

Linde was convicted in 1992 of violently shaking another 2-month-old son, Jacob, causing permanent brain injury. He served about six years in prison for the 1991 assault and an unrelated kidnapping and attempted sexual assault of a 10-year-old girl in 1992.

In Monday's sentencing, he was accused of shaking his son, Christopher, in early July, causing severe neurological damage. "I was hoping he would stay in prison forever," said Kathy Williams, Christopher's grandmother.

She read a statement from Linde's wife, Reginee, in Hillsborough County Superior Court.

"I wish I had never met you," Reginee Linde said in the state-

ment. She also wrote, "I truly hate you for what you've done."

The plea bargain was fair, said Mark Sisti, Linde's lawyer. "Cases like this are an absolute tragedy," he said. "I think Barry wanted to lessen the impact as much as he could," Sisti said of the guilty plea.

According to prosecutors, Linde, 36, of Nashua, brought Christopher to Southern New Hampshire Medical Center in July after calling his wife at work and saying their son was limp and not breathing.

The baby was taken to Children's Hospital in Boston, where he died 21 days later, after being in a coma and on a respirator, Senior Assistant Attorney General Simon Brown said.

Doctors determined that the child had suffered severe shaken baby syndrome, a term used to describe signs and symptoms typically present in babies who have been shaken violently.
