JM Yeah I'd like to get some fresh air though I think it's hot.


SH That's ah as far as I'm concerned. But (inaudible) this, this will cool you up okay?

AB No.


SH Okay did you have any property there do you have anything that you keep there?

SH Okay you guys need all set do you need anything right now?


JC Just our mother.


