

1 A Yes.

2 Q Now, is it the case when Chad said you shouldn't
3 bring Kassidy to your mother's, that it was because
4 Kassidy had supposedly fallen out of Jeffe
5 Marshall's truck?

6 A Yes.

7 Q So it was because of bruises on the back of her
8 head in Jeffe Marshall's care that caused Chad's
9 concern?

10 A Yes.

11 Q Now, the State also spoke with you about child care
12 for Kassidy.

13 A Yes.

14 Q Do you recall that? Isn't the case that you were
15 looking for daycare on November 8th, 2000 for
16 Kassidy?

17 A Yes.

18 MR. CRONHEIM: May I approach?

19 THE COURT: Yes.

20 [Pause in proceedings - counsel conferring].

21 [By Mr. Cronheim]:

22 Q Amanda, I'm showing you what's been marked for ID
23 as Defendant's Exhibit A, and ask you if you
24 recognize that?

1 A Yes.

2 Q And what is that?

3 A That is a list of daycares that I wrote down.

4 Q Okay. And how many different daycare centers are
5 listed on that sheet of paper?

6 A Seventeen.

7 Q Okay. I'm now going to show you what is a page, a
8 computer printout of phone records from Chad's
9 phone that's been marked as Defendant's Exhibit B,
10 for ID, and ask you if you can look at each of the
11 checked calls -- and, first, how many check marks
12 are there? There's seven?

13 A Yes.

14 Q Looking at the first check mark, 207-439-2474, is
15 that on your sheet of daycare providers?

16 A Yes.

17 Q And is that the ABC Preschool?

18 A Yes.

19 Q Next, I'll ask you to look at the second check mark
20 and the number 207-439-4444, and ask you if that
21 number is on the sheet?

22 A Yes.

23 Q And that's Strawberry Jam Child Care?

24 A Yes.

1 Q Next, I'll ask you to look at 207-439-6306, and ask
2 you if that number is on your sheet?

3 A Yes.

4 Q And is that another phone call on November 8th,
5 this one to Kids' Corner?

6 A Yes.

7 Q Next, I'll ask you if 207-439-9369, is on your
8 sheet?

9 A Yes.

10 Q And is that also a listed phone call to Carla
11 Downs' Daycare Center?

12 A Yes.

13 Q Next, I'll ask you if 207-439-2357 is listed in
14 your handwriting on your sheet of paper?

15 A Yes.

16 Q And is that phone number listed on the phone record
17 for Rainbow Daycare and Nursery School in Kittery?

18 A Yes.

19 Q And next, the sixth one, I'll ask you whether
20 207-439-6672, is a listed number on your
21 handwritten sheet?

22 A Yes.

23 Q And is that phone number reflected on the printout
24 as Karen Burbank's Daycare? I guess her name's not

1 there.

2 A Yeah, her name's not there.

3 Q Do you see that her number's there, and her name is
4 on your sheet of paper?

5 A Yup.

6 Q And for the seventh call, do you see 207-324-0735
7 as a listed number?

8 A [No audible response].

9 Q On your sheet?

10 A [No audible response].

11 MR. CRONHEIM: May I approach?

12 THE COURT: Sure.

13 THE WITNESS: Oh seven three five?

14 [By Mr. Cronheim]:

15 Q And that the computer printout shows it to be
16 Carelink Child Care?

17 A Yeah, I called for a package, a daycare package,
18 actually, because that was my last resort, because
19 I wasn't getting any daycares.

20 MR. CRONHEIM: I'd ask these two be entered as full
21 exhibits.

22 THE COURT: Any objection?

23 MR. BROWN: No objection.

24 THE COURT: Okay. They may be marked as full

1 exhibits.

6 [By Mr. Cronheim]:

7 Q So the early afternoon of November 8th was spent
8 calling daycare centers in order to find a place
9 for Cassidy?

10 A Yes.

11 Q And that was because by that time you were working
12 at Old Navy?

13 A Yes.

14 Q And it was time that Cassidy had proper daycare?

15 A Yes.

16 Q Now, after those phone calls, it's my understanding
17 that you dropped Cassidy off at Jeffe Marshall's,
18 correct?

19 A Yes.

20 Q And she was, other than being somewhat tired, she
21 was in reasonably good physical condition?

22 A Yes.

23 Q She had some marks and bruises on her face,
24 correct?

1 A Yes.

2 Q That she was walking around?

3 A Yes.

4 Q Alert, with her average appetite, which was a
5 pretty healthy appetite?

6 A Yes.

7 Q After you drop off Kassidy, you looked for the
8 dress, and you go to work, correct?

9 A Yes.

10 Q And at some point, I think you said in the area of
11 7:30 or so, but during your shift, there's a time
12 that you have a phone call with Chad?

13 A Yes.

14 Q But before that phone call with Chad, Jen has
15 already told you that Jeffe doesn't want to take
16 care of Kassidy any more?

17 A Yes.

18 Q And then you have a phone call with Chad, and to
19 some extent he's saying the exact same thing?

20 A Yes.

21 Q And it's at that time that Chad tells you about the
22 whiffle ball hitting Kassidy's face?

23 A Yes.

24 Q And did you have any reaction to that like, no,
