On June 6, 2001 at approximately 1745 hrs this writer received a telephone call at my residence from:

Sgt. James WHITE
Major Crime Unit

Regarding an ongoing investigation involving a suspect identified as:

Chad EVANS

Sgt. WHITE requested that we attempt to determine if EVANS was violating bail conditions by meeting with the mother of the child victim of this case. He advised me of the vehicle descriptions and residences involved. Sgt. WHITE also provided the pertinent information to Trooper Shawn SKAHAN.

I was in the process of calling Trooper SKAHAN at his residence by telephone when he arrived at my residence at 1800 hrs. He agreed to handle the request from Sgt. WHITE.

I went out in my personal vehicle and personally checked the residences at 651 Park Ave, Keene, 71 Sullivan Street, Keene and the place of employment, Domino's on Main Street in Keene and I was unable to locate any of the defendant's vehicles other than the red Mazda RX-7 which was parked at 71 Sullivan Street. It appeared that it was not driveable in that there was an obvious growth of grass around the tires.


I met Trooper SKAHAN at his residence and we made a call to Domino's Pizza and were able to determine that EVANS was not at work and the employee we spoke to was not sure if EVANS was coming to work. I made the telephone call and I did not indicate to the employee who I was, other than a friend looking for EVANS.

I secured at approximately 2030 hrs and Trooper SKAHAN maintained the detail until 0030 hrs.

On June 7, 2001 I signed on duty at 0730 hrs and checked the addresses again for the presence of any vehicles. I did not observe any of the described vehicles at the 651 Park Ave address, and when I arrived at 71 Sullivan Street, I observed the red Mazda RX-7 and the 1987 GMC pickup truck bearing NH registration 120 5625 in the driveway at 0752 hrs.

At 0756 hrs the GMC left the 71 Sullivan Street address and headed south on Sullivan Street and west on Knight Street. I was out of position and I was unable to follow the vehicle. I noted that there were two males in the vehicle and the driver was larger than the passenger.

I went to 651 Park Ave and maintained a surveillance on that location until 0830 and there was no activity at the address.

I was later informed that EVANS arrived in Portsmouth in a Volvo. I did not observe any Volvo's but Trooper SKAHAN advised me that when he last checked the 71 Sullivan Street residence, there was a Volvo parked in the driveway at 0030 hrs.

The Volvo was not in the driveway at 71 Sullivan Street when I checked both on the evening of June 6, 2001 and on the morning of June 7, 2001.
