This writer was charged with the responsibility of keeping a log pertaining to the activities of Chad EVANS as follows:

2200 Hours: Surveillance units in the vicinity of Domino's Pizza. Chad EVANS is inside the store and the Red Mazda RX-7 is parked near the back door. The registration plate on the Mazda is N.H. Reg. 118838.

2242 Hours: Chad EVANS leaves in the Red Mazda with a pizza for delivery.

2257 Hours: Chad EVANS returns to the rear of Domino's and goes back inside the store.

2315 Hours: Chad EVANS leave with another pizza delivery.

2323 Hours: Chad EVANS returns to the rear of Domino's and goes back inside the store.

0002 Hours: Chad EVANS leaves with another pizza delivery.

0020 Hours: Chad EVANS returns to the rear of Domino's and goes back inside the store.

0045 Hours: Chad EVANS leaves with another pizza for delivery, but departed with a male that has been hanging around the front of Domino's Pizza and talking on a cellular telephone. This male is dressed in light colored pants, and has on a dark colored sweatshirt or sweater.

0120 Hours: A Maroon colored Toyota pickup truck arrives at the rear of Domino's Pizza. The target and the same male that left with him in the Red Mazda returned in this vehicle. NOTE: This vehicle now sported the Domino's Pizza sign on its roof.

0210 Hours: The male subject that was hanging around with EVANS walked down the street in a westerly direction from the rear of Domino's Pizza. This male is taking notice of all vehicles in the area, and looked closely at this writer's vehicle in a church parking lot diagonally across from the rear of Domino's Pizza.

0218 Hours: A car drives into the church parking lot and stops with it's high beams on this writer's vehicle for about 10 seconds and peels away.


0229 Hours: EVANS came out of the store, took the sign off the truck, and went back inside the store.

0253 Hours: Sgt. YORKE advises that some activity is taking place behind the store and it looks like EVANS is getting ready to leave as he carries a bag out to his vehicle.

0258 Hours: EVANS and a female employee exit the rear door of Domino's Pizza and lock-up.

0259 Hours: EVANS shines a spot light on the car that the female is getting into. This light is coincidentally pointed at the Surveillance Van as well.

0301 Hours: EVANS is on Washington Street and doubles back at a school parking lot before taking Cottage Street to Sullivan Street and home. This was an obvious counter surveillance move by EVANS.

0400 Hours: EVANS is on the move out of Old Concord Road, up Washington Street toward Rte. 9.

0401 Hours: This writer can't locate the Toyota on Rte. 9 so I head toward Concord, Trooper HUSE goes back into Keene, and Sgt. YORKE is north on Rte. 10 to locate the Toyota.

0404 Hours: Trooper HUSE locates EVANS on Rte. 9 near Troop C heading west toward Chesterfield, NH and the Vermont boarder.


0433 Hours: Target is S/B on Interstate 91 in Brattleboro Vermont.


0438 Hours: Target exits the Interstate at exit 1 and travels southbound on Rte. 5.

0441 Hours: All units are in the area of Vernon Vermont behind the target who is acting very suspicious as the only vehicle(s) behind him have been Trooper HUSE and Sgt. YORKE for more than a half-hour.

0443 Hours: Surveillance has been terminated. The target began tailgating Trooper HUSE on Taylor Hill Road, shining a spotlight on him, screaming for him to stop, and acting erratic.
