

OBJECTION TO STATE'S MOTION FOR RECONSIDERATION


NOW COMES Chad Evans and, by his attorneys, objects to the State's Motion for Reconsideration.

WHEREFORE, defendant requests that the State's Motion for Reconsideration be denied.


